

Terms and Conditions

Circuits of the EURL CannesVisiTour, SIRET 802 701 102 00013, are contracted by the terms below. In this text are designated by:

- " CannesVisiTour ": the service provider "Participants" All client more than eight years old

1. Definition of prestations

CannesVisiTour realize a prestation of discovery tour on gyropode for a definite period with participants. Circuits are preceded by a training of equipment using and of safety rules respect during these circuits

Each participant which is recognized able, can obtain on demand his Gyrolicence, allowing him to practice the circuit.

The circuit is organized and supervised by at least one instructor.

2. Confidentiality policy
CannesVisiTour uses carefully your personal informations. The personal datas are used strictely to determine your identity, as your name, address and phone number. We collect your personal data only for your order processing.

3. Equipment available to participants

Participants acknowledge that they have had at their disposal equipment in good working order. If participants noticed a malfunction about equipment at their disposal, they should immediately report it to the instructor. A helmet is loaned during the tour time.

4. Obligations of participants

Participants acknowledge that they have done the preliminary and compulsory training course of safety rules and of driving. Participants make a commitment to respect all the safety rules taught in this session.

Participants assume keeping the equipment for the circuit duration. In particular, they warn immediately the instructor every time he leaves the equipment on public roads.

- Participants do a strictly personal use of the equipment available to them, they agree to use it according to the explanations that have been provided to them at the training. The participant is fully responsible for the offenses that he commits and assumes any fines or penalties.
 - The participant declares that he has a liability insurance and individual insurance against body accidents which cover him in case of use of Gyropodes.
 - Minors must be accompanied on the authority of an adult (parent, family, guardian, accompanying...)
 - In case of stolen equipment resulting from participant negligence, this one makes a commitment to pay the price of the equipment lent to its replacement value.
 - The consumption of alcohol, drugs and medicines is prohibited before and during our tours and any client suspected of having used it, will be immediately deprived of the prestation and no refund will be granted.
 - The participant declares that he has not a disease or disability that prevents him from using a Gyropode

CannesVisiTour shall not be liable:

- Damages caused by participants on equipment or themselves.
- Damages caused by the participants following an abnormal use or following a manipulation in contradiction with the modalities of use explained during the training and so resulting from the carelessness or from the fault of the participant.

5. Conditions

- · CannesVisiTour reserves the right to refuse the participation of any person who, in the opinion of a representative of cannesvisitour, is unable or unsuited to move on
- Wearing a helmet is obligatory for using the gyropode.
- For their comfort and safety, participants must wear closed shoes. Flip-flops, sandals and high heels are prohibited and handbags also.
- Participants under age 18 years old must be accompanied by a parent or guardian who assumes full responsibility for behavior and use of equipment.
- Participants are responsible for all damages caused on the equipment and will have to pay back the replacement cost of damaged parts or repair it, according to the
- \bullet The minimum age required to participate to our circuits is: 14 years old.
- The minimum weight required to participate to our circuits is: 25 kg.
- The supported maximum weight is 110 kg

6. Reservation or cancellation

6.1. Reservation

The purchase is considered as definitive as soon as the total amount is paid in advance by credit card, Secure Payment.

6.2. Modification or cancellation of reservation

By the client:

- 1/ 11 Days before the service offer date, the client can cancel or modify his purchase in return for paiement:
- 10€ per participant, in case of cancellation
- 5€ per participant, in case of modification.

He necessarily has to do the request at least 11 days before the date planned of the service by the contact form on the Web site: www.cannesvisitour.com or in reservations@cannesvistour.com

2/ Under 10 days before the prestation date, whatever the reason, no refund will be made.

By CannesVisiTour:

CannesVisiTour reserves the right to modify the circuit and the schedules according to the weather report, the circulation on the pedestrian ways and other events damaging his good realization without his demanding of payback even partial or any compensation.

CannesVisiTour keeps the possibility to refuse his services to every participant which is considered unable to drive safely during the circuit. This one can then participate in a circuit adapted to its capacity during another session

Any reserved or begun circuit is totally due by the participants. No refund will be made.

In case CannesVisiTour could not honor the execution of the prestation, notably because of extreme weather conditions, CannesVisitour will inform the Customer as soon as possible and will propose to participants another date of availability for the same service. If the customer cannot make available, then CannesVisiTour will pay off the totality of the service.

7. Local Conditions

8. Obligations of the company
